	 went up extremely fast, fully engaged in a couple of minutes. 4 properties damaged including one with no insurance. 3 fire departments, 33 fire fighters, had to bring in excavator. traffic issues - people impeded firefighters (looky lous and neighbours). trucks didn't use the gate through Poplars as it is private property and too dangerous to take large equipment through. 1908 Gower Point Road MOTI and SCRD descended together and issued stop work order. development permit is expired. Sunnyside Park the official line is in my newsletter and on the ECA Facebook page. as part of original development was supposed to be transferred to SCRD as a park, but land transfer never went through. sewer system serves 11 properties, currently 8 users.

Committee Reports

Chaster House/Park Report

Two developments over the summer.

Chaster House bridge has now got a consultant coming up with alternative bridge designs c/w costs for community and SCRD Board consideration. At the time of the meeting in early September there were three options being considered. All involved higher bridges. The options are shown on the attached map. The intention was to design a completely new bridge from well beyond the creek boundaries that didn't infringe on any jurisdictions requiring lengthy studies for approvals. (I'm not sure that is possible.) The consultant was promoting Option 1 as his favourite at the time of the meeting. A report

with preliminary designs and costs for a 4-foot-wide pedestrian bridge at each alternative location will be forthcoming. A 6-foot-wide bridge costs 50% more than a 4-foot-wide bridge. The community as a whole will have a chance to comment on the alternatives. The option of simply repairing the bridge foundation was not thought to be viable given the high overflowing flows being experienced nowadays. Removing old bridge abutments, widening the creek channel and repairing the retaining wall (all needed) were considered to be a second phase of the work to be done later, separately.

A community lead improvement project (CLIP) was submitted to SCRD Parks for hiring a Coastal Engineer to come up with ideas for protecting Chaster Park from erosion. SCRD Parks informed us that budget constraints were such that only urgent/emergency projects were going to be considered in next year's budget 2024. The cost is going to be roughly \$75k for the Coastal Engineer's study and probably another \$25k before there are any shovels in the ground for some (much?) cheaper physical work. It sounds like a lot of money but I reckon that is what oceanfront/riparian development is costing these days to get permits. Governments make the rules, now even they have to live by them. However, to realistically have SCRD staff budget that amount of money and SCRD board approve it there has to be a real community need. I think Chaster Park is a pretty heavily used park, it is eroding away when there are big storms from creek flow and ocean waves. We probably need a good letter outlining the community usage and park's deteriorating condition to go to SCRD Parks (again). Unfortunately, the SCRD Parks manager we have been working with has now left and I'm not sure where any of this stands.
