Donna introduced Kylie Hutchinson from TraC to give an update on safety improvements proposed at the intersection of Chaster and Pratt Roads. Here's some information about TraC:

TraC is a member-based organization that works to support healthy communities and reduce the Sunshine Coast's carbon footprint by promoting more active and sustainable transportation alternatives to private vehicles, including cycling, walking, and transit.

Here are a few notes from Kylie's presentation:

- Active travel for kids in partnership with VCH and school • district. Trying to get kids out of cars - get them walking and cycling.
- Hired a consultant re school crossing safety Langdale and • Cedar Grove elementary were schools chosen. Pratt and Chaster crossing of concern - collected data re volume and speed of road users – recommendations included – speed

limit is 50 they found 85% were going 59 to 63k.

• Roads are designed to encourage speeding.

	 The official Guide requires a crossing every 2-400 meters near a school – Cedar Grove is way over the threshold. For number of vehicles the threshold is 25 per hour– recorded at 45 per hour. Daily threshold 1500 they recorded 4300 – 7300 way over threshold. Yes, a crossing control is warranted at this location. Volumes will increase with development of Gospel Rock. Recommended rectangular flashing beacon or a 4-way stop – cost of beacon \$25,000, 4-way is less. This was raised with MOTT years ago. Tamara – she has been working on this for years and wholeheartedly thanked TraC. What can we do further – to get the beacon vs 4-way – because of seniors and very young children managing crossing a 4-way is onerous. Kylie indicated they are presenting to the school board, Silas White (mayor of Gibsons) is aware, Randene Neall (BC MLA) also aware. They are really pushing for a beacon. Q – have any other measures have been considered to help reduce speed? A – not really – ministry views pedestrians as the problem because they want a smoother passage for vehicles. This approach is changing throughout the province now because of the health impacts. Q – Michael wants to see a stronger call to action from the community. Asked Donna in her next newsletter to call the community to action. A. TraC working on connect the coast – trying to find people in MOTT who have the power to support change. Making slow progress. Donna said she is seeing progress with new MLA and making connections higher up the chain. Randene is having some talks with MOTT. ICBC also aware of the study and they can be helpful.

Committee Reports

1. Chaster House has some access improvements approved by SCRD Board 2025 budget as follows:

As per Board Resolution #177/24, this budget proposal is for upgrades to the alternate access to Chaster Park (eastern side of the park) and includes: upgrades to the gravel pathway to better improve safety and durability (e.g. grading, lighting), improvements to accommodate loading and unloading of supplies for booked events, parking improvements to the existing spaces along Ocean Beach Esplanade Road and improved signage.

The proposal also includes decommissioning and removal of Chaster pedestrian bridge, concrete abutments and other associated infrastructure, as well as revegetation of impacted areas with native species to restore riparian habitat along Chaster Creek.

Do we want to volunteer to help out with revegetation? We could also ask to make community garden boxes or ground level plots for nearby gardening enthusiasts as I know there is old stone free soil in the area where the access is going to be located. How much do we want to be involved? Should we apply for funding from the Vancouver Foundation (if that fits)?

2. BCTS update:

We need to prepare for BCTS presentation on March 19 regarding how to advertise the presentation, what we want presented, question format and safety of the speaker/meeting control. Also there is an invite available to examine the logging block which I would like to advertise at the Feb GM. Further, I'm hoping we will receive a written BCTS response to our letter soon. We should distribute that for comments when we get it as I'm supposed to provide more feedback to BCTS before March 19.

3. Clark Trail or Chaster connector trail:

This is the one that goes from Sunnyside near Clark to Chaster Rd near Cedar Grove school. SCRD has asked me what ECA might be able to provide to help with this maintenance as follows:

Is there an interest from volunteers to assist with aspects of the project?

- What is the capacity for volunteers to assist with the project? How many volunteers would be available? Are weekdays possible or are volunteers only available on weekends? Do volunteers have preferred times of day?
- Would volunteers be available to assist with the following activities (activities are contingent on final design plans and will be confirmed prior to the start of the project): removing current infrastructure, brushing (FireSmart treatments), spreading aggregate, installation of boardwalk, securing donations of materials (possibly aggregate, culverts, etc.), clean-up activities postwork.
- If there is interest, please provide the names and email addresses for those interested and what tasks they are interested in.

How should I answer? Rod has approached the credit union for funding. Do we want to apply? Another source might be the Sunshine Coast foundation but the only give funds to CRA charities. Does anyone know a charity to partner with?

Dear Minister Neill,

We write to you on behalf of the residents of Elphinstone (SCRD Area E), the community in which, on December 6, 2024, another pedestrian was struck and killed by a motorist while attempting to cross Highway 101 west of Gibsons.

The section of 101 adjacent to Woodcreek Park and The Poplars has been the site of at least three similar fatalities, one of a 12-year-old child. The residents of these two densely populated developments on the south side of 101 have been pleading for a safe crossing to the west bound bus stop for years. Many have concluded that using public transit is too risky, creating a Catch-22 reality in which ridership is too low for the transit authority to justify bus stop redesign.

In our view, a reduction to the speed limit on this section of road will not, by itself, be adequate. Observations of motorist behaviour shared with us suggest a widespread belief that using the shoulder or bus stop on the north side of 101 to pass left turning vehicles is both legal and appropriate to maintain the flow of traffic. This belief is also commonly expressed by a subset of local motorists on social media.

We believe that a reduction in speed must be accompanied by additional traffic calming measures such as a well-lighted pedestrian-controlled crosswalk. The residents most affected by this deadly crossing have experienced too much loss and waited much too long for their safety to be addressed. We urge you to support a solution that will finally result in safety for this community.
